Q2 2017 Review
Focus on IPOs and Public Company Takeovers

A year ago we focused on the dwindling US public technology market, specifically lackluster initial public offerings (IPO) and robust public company acquisition activity. The trend continued into 2017, albeit at a slower pace.

In the first half of 2017, the IPO market seemed to pick up. 2017 started with Cisco's January announcement to acquire IPO candidate, AppDynamics, for \$3.7B, nearly 19x revenue. Nevertheless, 13 technology companies went public in the first 6 months of 2017, compared to 16 for all of 2016. Notable IPOs included Cloudera, MuleSoft, and Snap.

Acquisitions of public companies slowed in 2017, with 20 transactions completed in the first half of 2017 versus 61 transactions completed for all of 2016. 2016 seemed like an unusually active year for public company acquisition activity, with strategic mega deals, Dell-EMC, Microsoft-LinkedIn, and Avago-Broadcom, closing. Given the brisk acquisition activity in 2015 and 2016 and the lackluster IPO market, the number of public company targets declined. As a result, we believe the slower acquisition activity in 2017 is because of higher than normal acquisition activity in 2015 and 2016, a decline in public targets, and the need for acquirers to focus on acquisition integration versus a lack of investor appetite.

Regarding IPOs, private equity and corporate investing groups are providing better terms than the public markets. Private investors take a longer-term view on earnings potential than public market investors and will often overlook the quarterly

inconsistencies that result in public company valuation swings. The cost of corporate governance is often less for private equity owners than for public markets. As a result, we expect measured IPO activity to continue for the foreseeable future.

Regarding public company acquisitions, large corporations and private equity groups are acquiring technology for innovation as well as customer synergies, technology synergies, and operational efficiencies. Many investors see the opportunity to consolidate fragmented parts of the industry. Additionally, activist investors in public technology companies are pushing some public company boards towards a sale.

We see continued interest in technology from strategic and financials buyers that are flush with cash and can borrow at low interest rates. Private markets have taken the place of public markets as a source of funding.

The path to liquidity for investors in private technology companies will be acquisition or recapitalization for the foreseeable future. To maximize a successful exit, we recommend that private companies form alliances with potential acquisition buyers early and keep a list of joint customers to validate the value to the potential buyer.

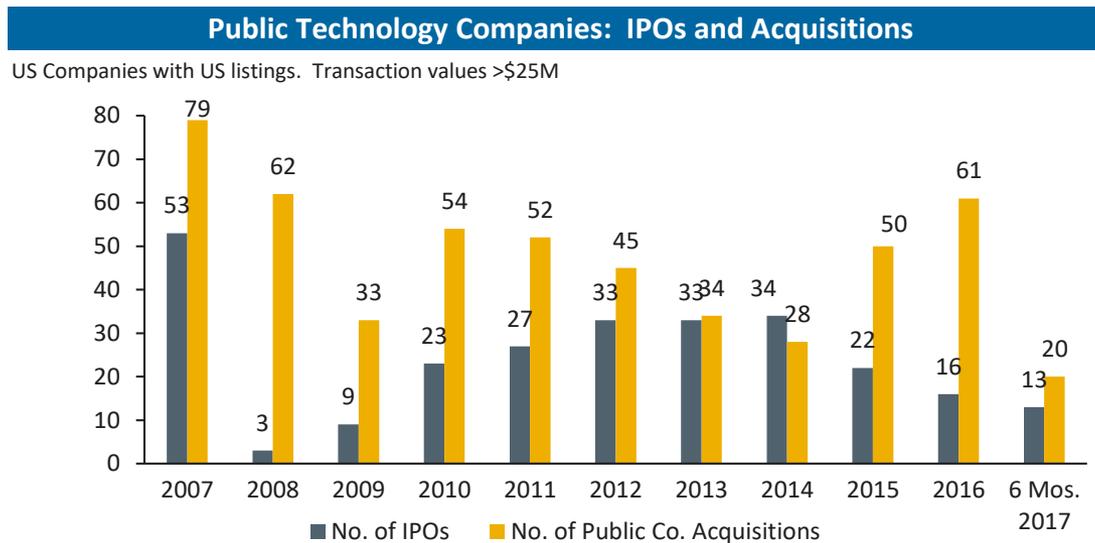

The private equity market and corporations are flush with cash and are providing better financing terms than the public markets. Also, growth capital and private equity investors are willing to pay a premium for longer-term earnings and have the patience for inconsistent earnings results. As a result, acquisitions of public companies continues to outpace the number of IPOs.

We believe the slower acquisition activity in 2017 is because of a difficult comparable in 2016, and a smaller number of attractive public company targets versus a lack of investor appetite.

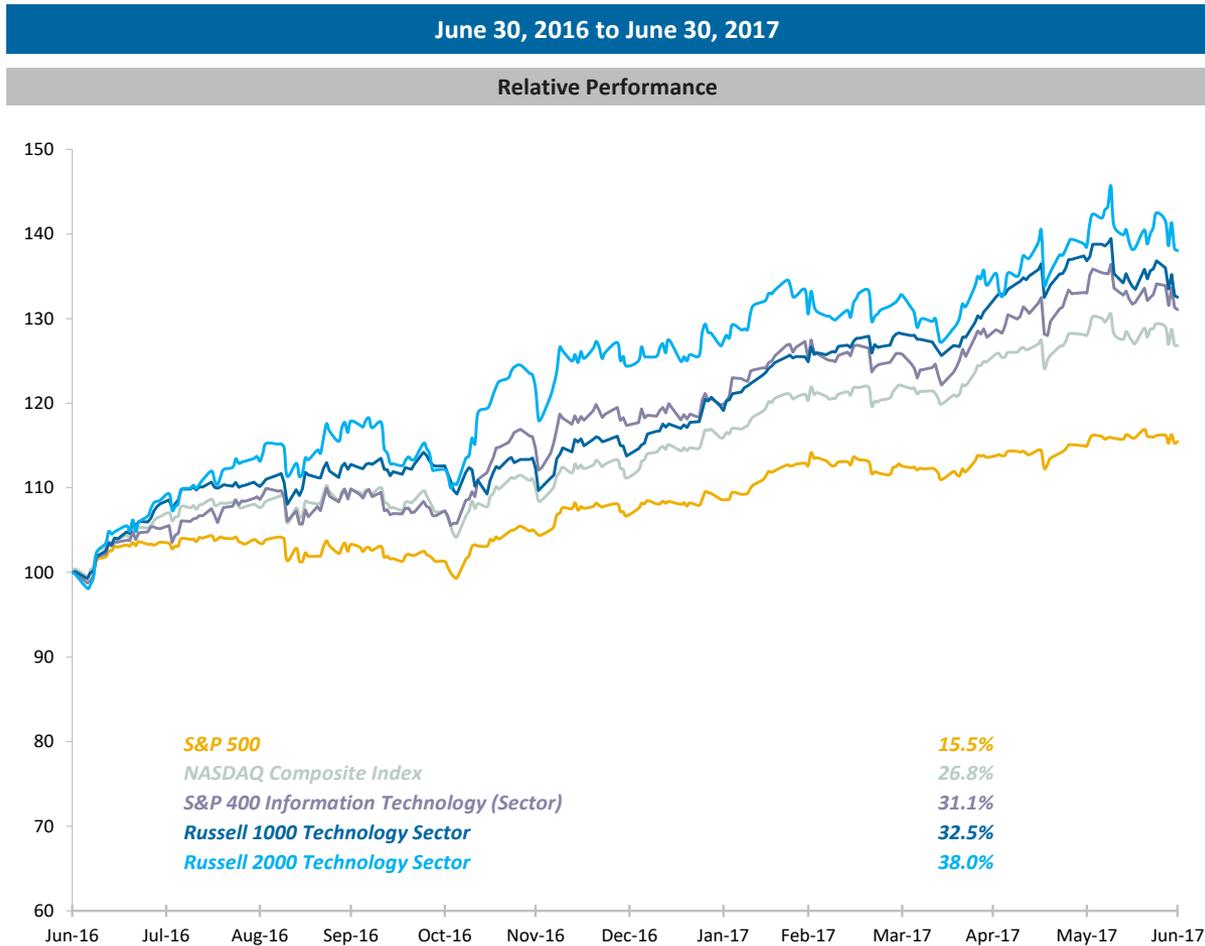
